## Mental Health Counselor Responsibilities:

- Provide individual, family, and/or group therapy with adult and/or child consumers and their families.
- May provide education/psychological testing or referrals as relevant or needed.
- Conduct initial intake and assessment of consumers.
- Participate in treatment planning with supervisory and consultant staff.

- Establish and implement time-sensitive and effective treatment objectives with each consumer and their family when appropriate.
- Respond to emergency consultation and/or crisis as needed or required.
- Inform, instruct, and assist consumers concerning the access of appropriate community resources.
- Identify, develop, and coordinate additional supportive and case management services as relevant to assigned consumers.
- Maintains appropriate documentation for consumers. Adheres to documentation requirements established by internal policies and procedures, state/county guidelines, licensing requirements, and other applicable guidelines. Complete all clinical documentation in a manner that is timely, accurate, and meets audit-tested requirements.
- Attend monthly virtual staff meetings.

## **Qualifications:**

- Master's degree in psychology, social work, or related field.
- LPC, LCSW, or LMFT preferred. LAPC, LSW, LAMFT, or pre-licensed will be considered.
